PRIVACY NOTICE

We Are Committed to Safeguarding Customer Information. To better serve your needs now and in the future, we may have asked you to provide us with certain information. We understand you may be concerned about what we will do with such information. Particularly any personal or financial information. We agree you have a right to know how we will utilize the personal or financial information you provide us. Therefore, we have adopted this Privacy Notice to govern the use and handling of your personal information. In addition, our title insurance underwriters named herein have adopted their own similar privacy notices and policies. Please note the policies stated herein are the individual policies of this company and while similar are not jointly instituted nor maintained with our underwriters. The term "our" or "we" as sometimes used herein may refer to Jones Raulston Title Insurance Agency, Inc. ("Jones Raulston") or one of the following title insurance underwriters: Chicago Title Insurance Company, Fidelity National Title Insurance Company, Commonwealth Land Title Insurance Company, and First American Title Insurance Company. Jones Raulston is a title insurance agent of each of the listed underwriters and remits a portion of the title insurance premium with the respective underwriter on your Settlement Statement or invoice. Jones Raulston also serves or has served as the settlement agent in your real estate transaction.

Applicability. This Privacy Policy governs our use of the information you provide us. It does not govern the manner in which we may use information we have obtained from any other source, such as information obtained from a public record or from another person or entity.

Types of Information. Depending upon which of our services you are utilizing, the types of nonpublic personal information we may collect include: Information we receive from you on application, forms and in other communications to us, whether in writing, in person, by telephone or any other means; Information about your transactions with us, our affiliated companies, or others; Information we receive from a consumer-reporting agency; Information from an internet web site; Information from public records maintained by government agencies; or information we receive from others involved in your transaction, such as your authorized representatives, real estate agents and brokers, lenders, appraisers, and other professionals in the real estate industry.

Website. The Jones Raulston website may provide links to third-party websites for your convenience and information. Such affiliated companies include financial service providers, such as title insurers, property and casualty insurers, and trust and investment advisory companies, or companies involved in real estate services such as appraisal companies, home warranty companies, title examiners, attorneys and law firms. Furthermore, we may also provide all the information we collect, as described above, to companies that perform marketing services on our behalf, on behalf of our affiliated companies, or to other financial institutions with whom we or our affiliated companies have joint marketing agreements. We may also share information in response to a subpoena, to a governmental agency or to prevent fraud or criminal conduct. One of our important responsibilities is to record documents relating to your transaction in the appropriate public records. Such documents may contain your personal information.
